

## **OFFICIAL CONTEST RULES**

#### **[JERSEY GIVEAWAYS]** **(the “Contest”)**

### **OFFICIAL CONTEST RULES**

- 1. ELIGIBILITY:** To be eligible to win, you must: (i) be a resident of Canada (excluding Quebec) and (ii) be 19 years of age or older. You are not eligible to win, if you are: a) an employee officer, director, agent or representative of Shark Club Restaurants, LP (the Sponsor), or any of its affiliates and related companies (including, but not limited to Moxie’s Grill & Bar, Chop Steakhouse & Bar, Sandman Hotels, Sandman Signature Hotels, Sutton Place Hotels, Denny’s Canada), any participating stores or the prize suppliers; b) an employee or contractor of a provincial liquor authority, a beer distribution company or a participating licensed establishment, or, in the case of residents of British Columbia, any provincial liquor authority or liquor licensee; or c) a member of the immediate family (defined as parents, siblings, children and spouse, regardless of where they live) or household (whether related or not) of any of the above persons.
- 2. HOW TO ENTER: NO PURCHASE NECESSARY.** Contest begins on or around June 4, 2026, and will end at 12:00 pm PST on October 24, 2026 (the “Entry Deadline” and “Contest Closing Date”) at participating Shark Club licensed establishments in Canada. To participate, order a Coors Light at your participating location on any game day and receive an entry card to be entered into that day’s game draw; or enter without purchase by asking any server at any participating Shark Club locations for an entry card. To enter, fill out the Shark Club entry ballot provided by a staff member. All fields on the entry form must be completed unless they are otherwise indicated as optional. Limit: five (5) entries per person/email address per day. The Releasees (as defined below) will not be responsible for illegible, incomplete, lost, misdirected, or late entries, all of which will be void. For greater certainty and the avoidance of any doubt, you can use only one (1) email address to enter this Contest. If it is discovered by the Sponsor that any person has attempted to: (i) obtain more than the maximum stated number of entries as outlined in these Official Contest Rules; and/or (ii) use (or attempt to use) multiple names, identities and/or more than one (1) email address to enter the Contest; then he/she may be disqualified from the Contest and all of his/her entries voided. Your entry will be rejected if the entry card is not fully completed with all required information and submitted and received by the Entry Deadline. Use (or attempted use) of multiple names, identities, email addresses and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or disrupt this Contest is prohibited and is grounds for disqualification by the Sponsor. All entries are subject to verification at any time and for any reason. The Sponsor reserves the

right to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government-issued photo identification) to participate in this Contest.

3. **PRIZE:** There is one prize (the “Prize”) available to be won at each participating location during every game day of that Shark Club location’s designated team. The Prize consists of 1 Official Team Jersey per Game. Each location will have a total of 18 jerseys to hand out throughout the entirety of the Contest duration.

Prize is not transferable or assignable and must be accepted as awarded with no substitutions in cash or otherwise, except at the Sponsor’s sole discretion. Sponsor reserves the right, in its sole discretion to substitute a Prize of equivalent monetary value, if a Prize or any part of the Prize, cannot be awarded as described for any reason. The Releasees (as defined below) will not be responsible, however, if weather conditions, event cancellations, or other factors beyond Sponsor’s reasonable control prevent a Prize or any part of a Prize from being fulfilled. In any such event, winner will not be provided with a substitute Prize or cash equivalent. Prize will only be released to the verified winner. Return of any Prize/Prize notification as undeliverable may result in disqualification and selection of an alternate eligible winner.

4. **DRAWING:** At the end of each official game day of the participating location’s designated home team, one (1) entry card will be randomly selected by a staff member from all eligible entries received at the participant’s respective Shark Club location. Odds of winning depend on the total number of eligible entries received at that location for that game day.

9. **MISCELLANEOUS:** No correspondence will be entered into except with selected entrants. The Contest is subject to all applicable federal, provincial and municipal laws. In the event of a dispute regarding who submitted an entry, the entry will be deemed submitted by the authorized account holder of the e-mail address submitted at the time of entry. A selected entrant may be required to provide Shark Club Sports Bar & Grill with proof that he/she is the authorized account holder of the e-mail address associated with the selected entry. Sponsor reserves the right at its sole discretion to disqualify, from this Contest and any future Contests or other promotion conducted by Sponsors, any individual that it finds or believes to be not in compliance with these Official Rules and Regulations, to be tampering with the entry process; or to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.
